THE DUCK BLIND PET AGREEMENT

Pet Pawlicies at Between Water & Main reflect our concern for all of our guests - those with and without furry companions. We strive to promote positive actions that ensure our Bed & Breakfast continues to welcome our guests and their pets in the future.

Well behaved, healthy pets are welcome in The Duck Blind for an additional, non-refundable \$25 fee per pet (maximum 2 pets).

As a pet parent, I agree to and understand the terms of the PET PAWLICY as follows:

- 1. Cats and Dogs of all sizes are welcome, maximum 2 pets. Regretfully, will not be able to accommodate the following restricted breeds: Pit Bull, Rottweiler, German Shepard, Boxer, Huskies, Alaskan Malamute, Doberman Pinscher, Chow Chow, Presa Carnario, or Dalmatian.
- 2. Pets must be restrained (leashed or in a carrier) when outside The Duck Blind. No pets will be allowed in the main house.
- 3. In consideration of our other guests and the health of other pets, your pet is well groomed, has been spayed or neutered, is current with all required shots & immunizations and is up-to-date on all flea and de-wormer medication.
- 4. The pet parent is responsible for cleaning up any waste produced by pet. Refuse bags are provided. Indoor toileting accidents will be charged a non-refundable cleaning fee of \$250 for sanitary stain treatment, sanitary carpet cleaning, and sanitation of entire room.
- 5. Between Water & Main will provide substitute bedding to be used should your pet be accustomed to getting onto beds. If so, please ensure that your pet lays on appropriate areas that are covered by substitute bedding or place bedding on floor for your pet.
- 6. Pets are NOT ALLOWED to be bathed in the guest room, bathtubs, showers, or sinks. Please do not use our towels or linens to clean off or dry your pets or let your pet on our beds or furniture with wet or muddy feet. The Duck Blind comes with Pet towels for clean ups.
- 7. The pet parent agrees to accept full responsibility of the pet and for any and all damages and/or soiling caused by the pet during your stay at Between Water & Main. Between Water & Main accepts no responsibility for a pet or pet parent who does not follow the items listed on this agreement. The pet parent understands that the costs for the repair of any damages or additional cleaning requirements (including labor) will be charged accordingly, including: flea treatment of the guest room, carpet cleaning, replacement bedding, towels, furniture, paint, torn or ripped screens, and extra labor required to clean or repair room, if necessary.
- 8. Pet parent agrees to be liable for any injury to any person or any animal caused by their pet while on premises.
- 9. All Pet Pawlicies will be strictly enforced. The safety and comfort of all our guests is our utmost concern; therefore, Between Water & Main reserves the right to remove noisy, aggressive, sick, or misbehaving dogs from the premises without notice or refund. Failure to follow the Pet Pawlicy will result in the owners and their pet being asked to leave without refund and applicable damage or cleaning fee(s) issued.
- 10. A valid credit card number or a security cash deposit of \$250 is required to be on file at the Front Desk. In the event that your pet damages, soils, or does not abide by the policies set forth by Between Water & Main, you will receive an itemized statement outlining any applicable charges. You will be credited your deposit upon check-out once your room has been inspected.
